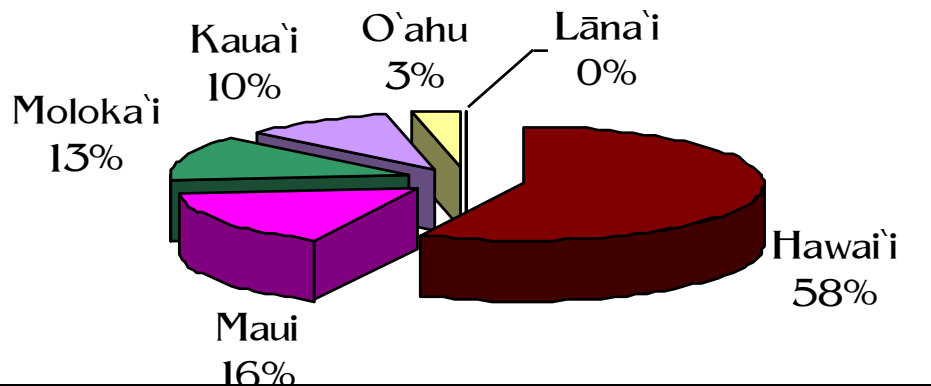

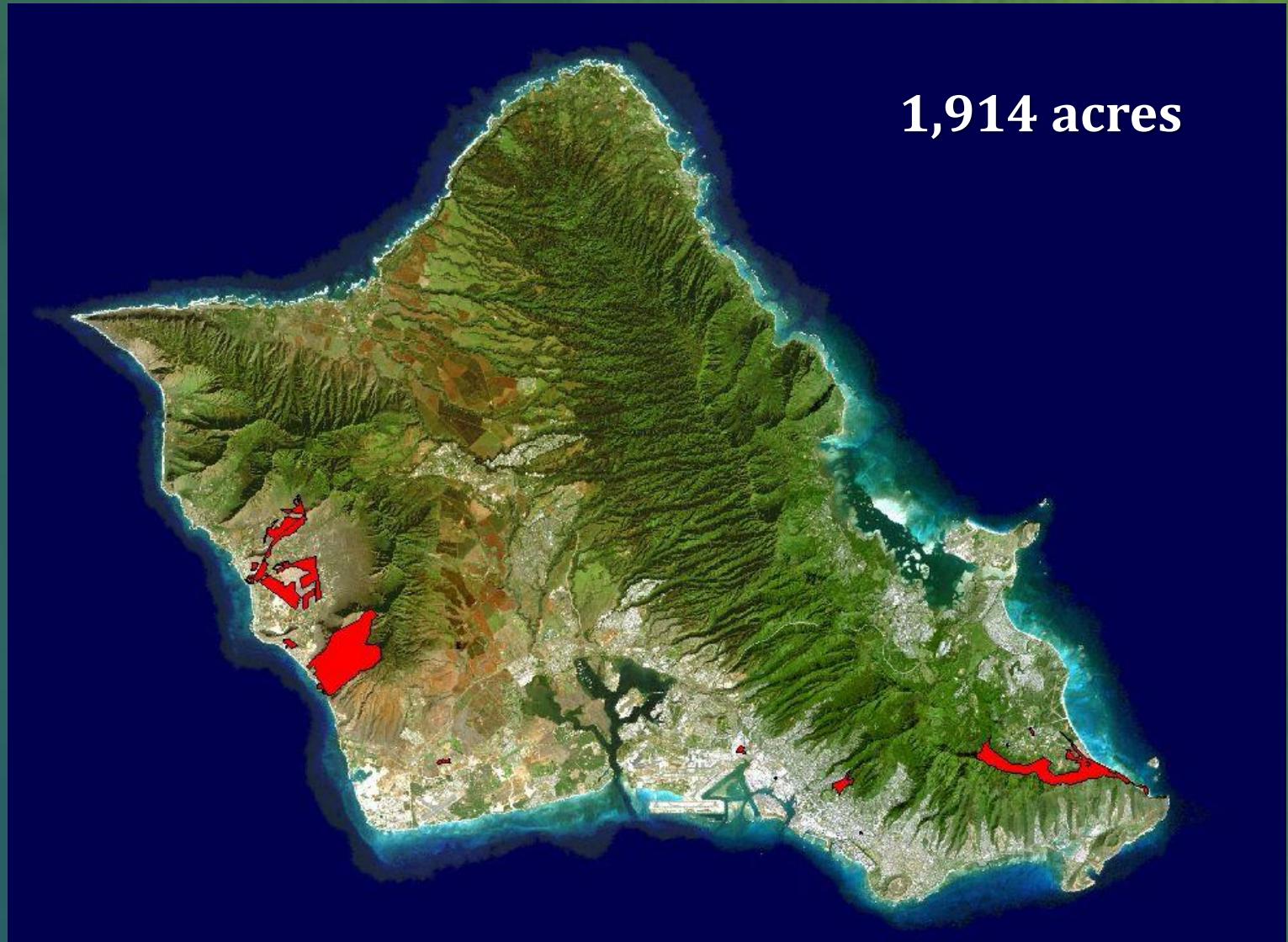
Hawaiian Home Lands Trust

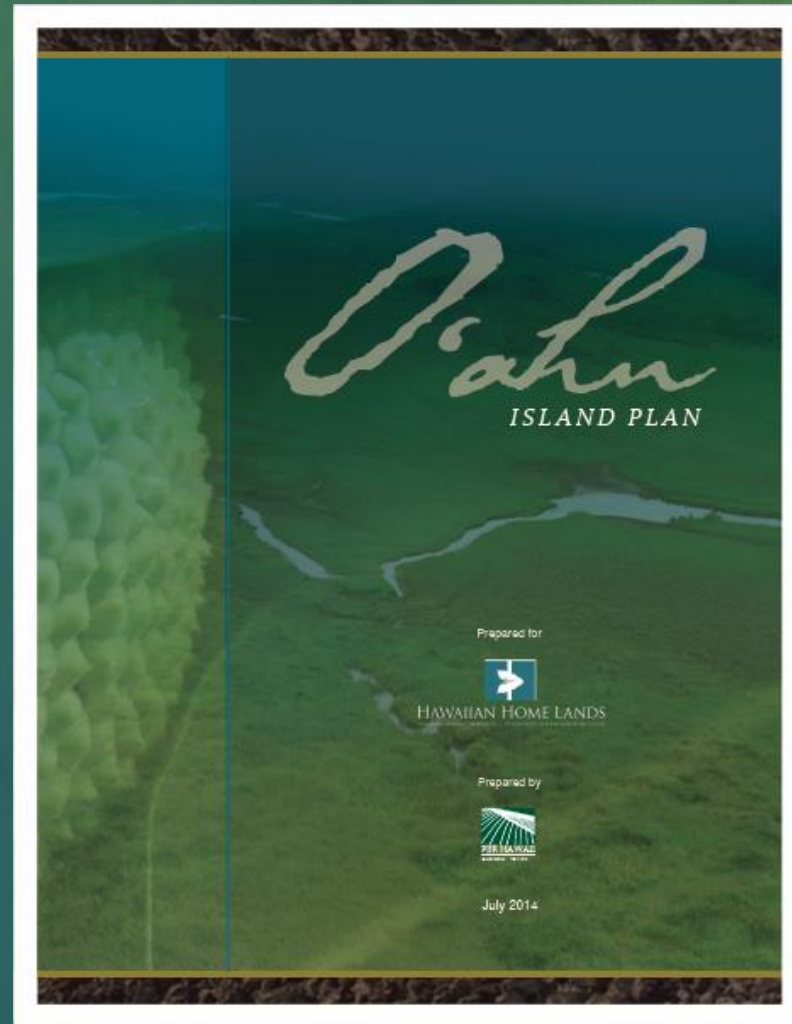

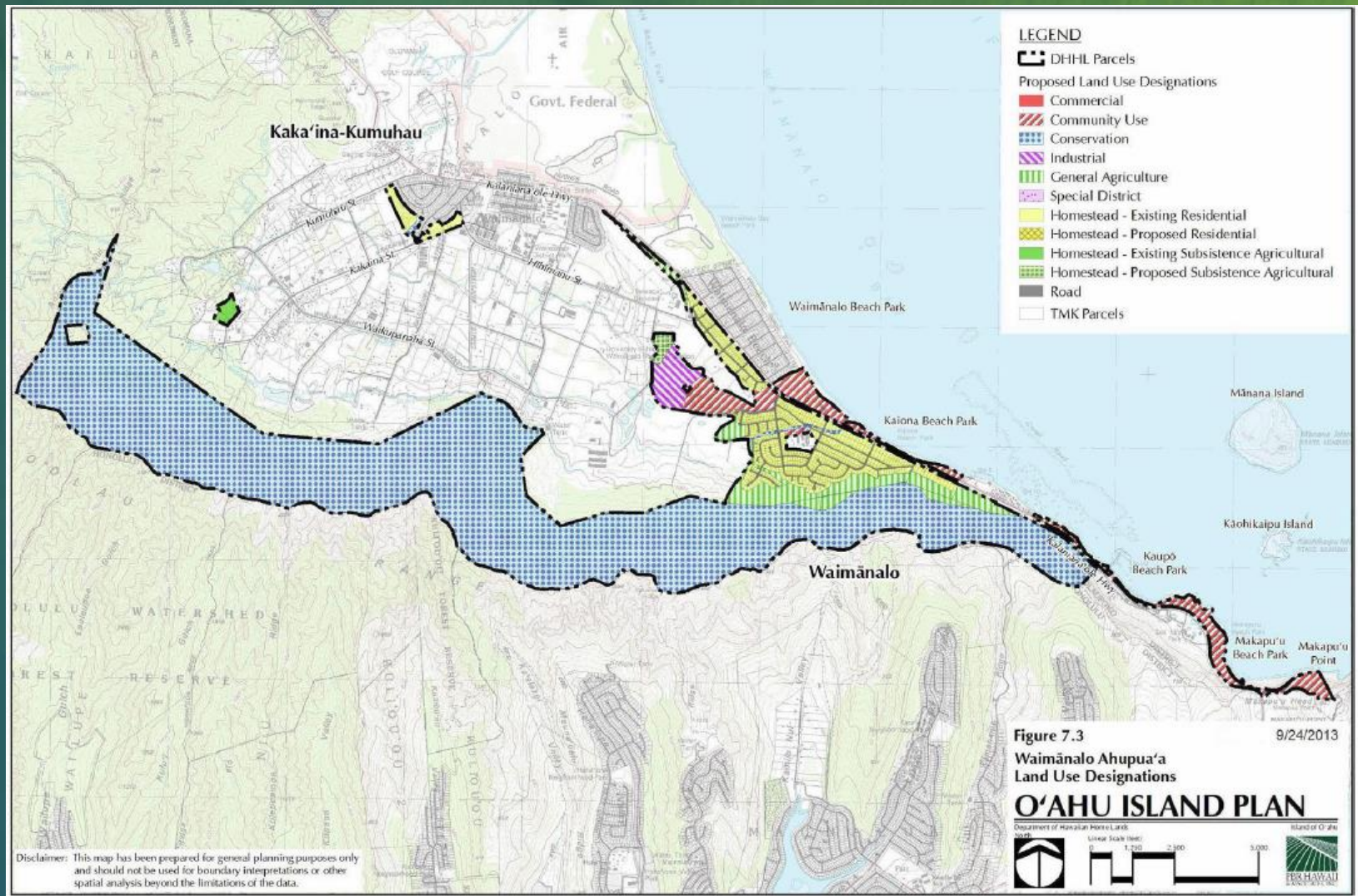

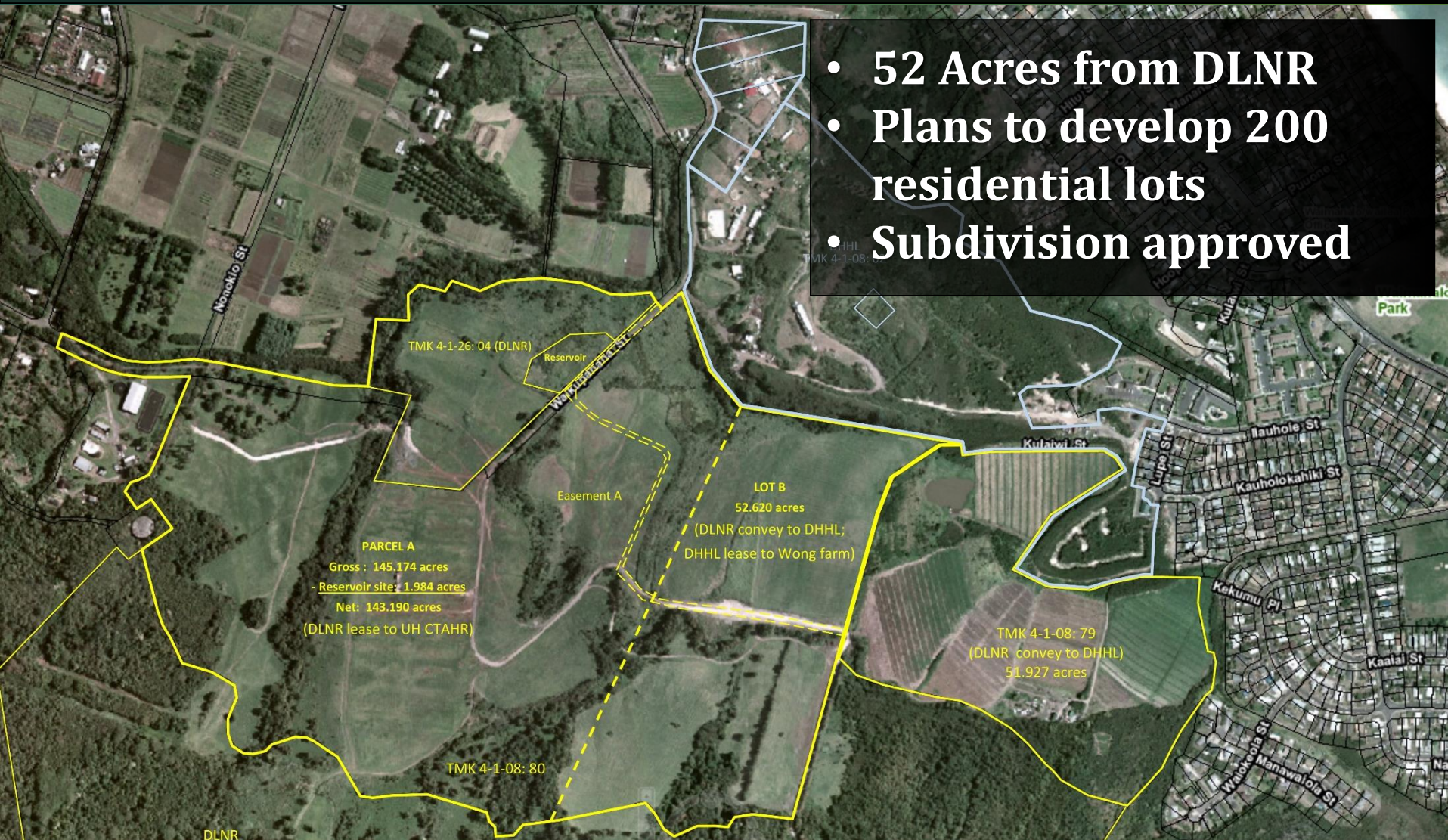
Kaka'ina Construction
