## General

- 1) CONTRACTOR'S BID SUBMITTAL Amend the BID OFFER FORM from Addendum No. 2 as follows:
  - a. On page 9 replace the last paragraph:

"The CONTRACTOR shall complete all work as specified or indicated in the Contract Documents on or before \_\_\_\_\_ calendar days after receiving written Notice to Proceed, subject to extensions, as may be granted."

## e. On page 16 in the first section, replace item 2):

"The Base Bid and Alternate, if any, of each Bidder will be adjusted to reflect the applicable preferences in accordance with Chapter 103D, HRS. The Alternate, if any, will then be added to the Base Bid and compared with the control amount."

The Base Bid and Deductive Items, if any, of each Bidder will be adjusted to reflect the applicable preferences in accordance with Chapter 103D, HRS. The Deductive Items, if any, will then be deducted from the Base Bid and compared with the control amount.

# f. On page 16 in the first section, replace item 3):

"The low Bidder shall be the Bidder having the lowest aggregate amount, within the control amount (after application of the various preferences), for the Base Bid plus the Alternate, if any."

The low Bidder shall be the Bidder having the lowest aggregate amount, within the control amount, for the Base Bid minus the Deductive Items, if any.

g. On page 16 in the first section, delete item 4) in its entirety:

"If adding the Alternate, if any, would make the aggregate amount exceed the control amount for all Bidders, the low Bidder shall be the Bidder having the lowest Base Bid after application of the various preferences."

h. On page 16 in the second section, replace item 2):

"After determining the low Bidder, an award may be made either on the amount of the Base Bid alone, or including the Alternate (exclusive of preferences), if:"

After determining the low Bidder, an award may be made either on the amount of the Base Bid alone, or including the Deductive Items, if:

i. On page 16 in the second section, replace item 2), part c.:

"The combination of the Base Bid plus Alternate does not change the apparent low Bidder."

The combination of the Base Bid and Deductive Items does not change the apparent low Bidder.

j. On page 16 in the second section, replace item 4):

"In the event the award is made for the Base Bid alone, the Chairman reserves the right to amend the contract at a later date to include the Alternate should funds subsequently become available."

In the event the award is made for the Base Bid alone, the Chairman reserves the right to amend the contract at a later date should funds subsequently become available.
