

RFP-23-HHL-001 Existing Facilities

Purpose: Grant for improvements to EXISTING FACILITIES on HHL

- "Existing Facility" means a physical asset that you currently manage and/or operate
- Site Control
- Funds available: \$3 million statewide
- Maximum per application: \$1 million
- Grant period: Six (6) years, with NO option to time extend
- Limit: one application per organization



RFP-23-HHL-002 Existing Programs

<u>Purpose</u>: Grant for EXISTING programs and Services for existing homesteads

- "Existing Program" means any program and/or service that you are currently operating, where clients/participants are primarily Lessees
- IN-eligible projects are (refer to page 13 in RFP):
 - Housing counseling; Homeownership assistance; Emergency assistance
- Funds available: \$4.5 million statewide
- Maximum per application: \$500,000
- Grant period: Six (6) years, with NO option to time extend
- Limit: one application per organization



Existing Homestead Services Requirement

Applies to RFP-23-HHL-001 AND RFP-23-HHL-002 ONLY

Funds are to be used to benefit LESSEEs, primarily.



RFP-23-HHL-003 Project implementation

Purpose: Grant for Project Implementation

Eligible: New facilities (due diligence, planning, design, construction)

- Any other programs/services (new or currently operating) for HHCA beneficiaries
- IN-eligible projects are (refer to page 13 in RFP):
 - Housing counseling; Homeownership assistance; Emergency assistance
- Funds available: \$700,000 statewide
- Maximum per application: \$100,000
- Grant period: Six (6) years, with NO option to time extend
- Limit: one application per organization



RFP-23-HHL-004 Community Capacity Building

Purpose: Grant for Community Capacity Building

This RFP seeks proposals to build, strengthen and enhance community capacity within the HHCA beneficiary community – Lessees and Applicants

- Funds available: \$300,000 statewide
- Maximum per application: \$15,000
- Grant period: Four (4) years, with NO option to time extend

• Limit: None. A single applicant may submit multiple proposals, <u>as long as</u> the proposed project is different

 - Assure proposal was received by DHHL in a timely manner
 - Assure DHHL can open and read the proposal
 - If needed, allows time for you to re-submit before the due date

Phase 2 – Grants Review Committee evaluation

See criteria 1 through 7

Proposal scoring:

• Organizational capacity 40 points

• Project readiness 30 points

• Beneficiary involvement 20 points

• Sustainability 10 points

BONUS POINTS

Applies to all RFPs
Match – up to 5 points

Applies to RFP-23-HHL-002 and 003 ONLY Regional Plan PRIORITY Project – 5 points

What's a good proposal?

Generally, characteristics of a good proposal:

- The proposal was complete and instructions were followed
- Proposed Scope, Budget, Timeline are in alignment
- Brief and concise well written, error-free
- Proposal has enough relevant information and documentation to help evaluators understand your proposal
- Applicant and project have strong connection to beneficiaries – eg board resolutions, support letters, etc.



A few last words...

- "Funder Fit"
- Don't CHASE the money.
- Apply for what you NEED. That's most important.
- Have a Project Plan.
- Proposals must address the criteria.

 These are competitive funds . . . not enough for everybody.
- Money isn't everything.
- Let's show DEMAND for Community Grants.
