ORDER OF BUSINESS

CALL TO ORDER

Chair Anderson called the meeting to order at 9:35 a.m. Seven (7) members were present at the meeting location, and one (1) via ICT, establishing a quorum.

Pursuant to Act 220, the Board shall be visible and audible to members and the public unless leaving the meeting. No other participants are required to be visible during the meeting. All votes shall be by oral consensus unless a roll call is requested.

Commissioner Teruya thanked the Chairman for his service and noted that she had questions from beneficiaries about his status. DAG Kanaka'ole stated the Governor appointed Chair-Designate Anderson under the Governor's Interim Appointment Authority pursuant to Article 5, Section 6 of the Hawai'i Constitution. The withdrawal of the nomination means there will be no confirmation. However, Chair-Designate Anderson can still serve until the end of the session unless a new appointment is made. Commissioner Awo thanked DAG Kanaka`ole for the clarification, as the question did come up in their mokupuni council meeting.

Chair Anderson stated that Public Testimony would be taken following the approval of the agenda. The Commission will convene for lunch and an executive session at around noon 90 minutes.

APPROVAL OF AGENDA

MOTION/ACTION

Moved by Commissioner Teruya, seconded by Commissioner Awo, to approve the agenda. Motion carried unanimously.

APPROVAL OF MINUTES

JANUARY 17 & 18, 2023, REGULAR MEETING

Chair Anderson asked if there were any edits to the January 17 & 18, 2023, Minutes and January 27, 2023, Special Meeting Minutes.

Commissioner Teruya stated for February 17, 2023, page 3, paragraph 4, the following should be inserted, "it is noted that Masagatani is still reviewing the past Minutes; why is she still reviewing the past Minutes for the Department." Page 5, 2nd to last paragraph, insert, "Pat Kahawailoa'a expressed concerns about allowing a past employee to review past Minutes."

Commissioner Teruya asked the Department to produce a list of vacancies and the type of positions, as indicated on page 12. Page 17, Juan Garcia was asked to provide an update on Nanakuli beneficiary Patrick James Mitchell's status.

For the Special Meeting, page 7, PT-13, the spelling should be Kurt Favella.

Commissioner Kaleikini stated for clarification, on page 2 of 28, he referenced appropriation for \$500,000 is by Senator Dela Cruz and the \$2 million is part of Act 279.

Chair Anderson asked if there were further discussions or amendments to the January 17 & 18, 2023, Minutes

MOTION/ACTION

Moved by Commissioner Awo, seconded by Commissioner Neves, to approve the January 17 & 18, 2023 Minutes with amendments. Motion carried unanimously.

PUBLIC TESTIMONY ON AGENDIZED ITEMS

PT-1 DeMont Manaole – Delinquent Right of Entries and Item F-3

D. Manaole testified that the non-Hawaiian companies could get the right of entry, but the Hawaiian companies could not. He wants the Commission to think about getting the Hawaiians off the month-to-month basis because it hurts them, as they cannot go to the bank and get a loan because of the month-to-month. If they have long-term, they can get funds to improve their businesses. He thinks Act 279 is good but questions the plan's validity because he was not contacted in 2020 during Covid. He sees the contact of the Associations and leaders, but what

about the 28,000 on the waiting list; who consulted them, and where is the evidence? He was told SMS did it.

PT-2 Kona Jugoz – Item F-3

K. Jugoz is the President of the Princess Kahanu Association (PKA). He asked that Governor Green release the General Funds awarded to their community by DHHL in December 2022. PKA contracted with an engineering company to design their new facility with the funds awarded in 2020 and the funds in 2022 to design their community center.

Commissioner Teruya stated she supports K. Jugoz's testimony and wants to clarify that the Governor needs to release the grant funds awarded in 2022. She asked Chair Anderson to call the Governor to release the funds.

Commissioner Helm agreed with Commissioner Teruya about moving the grants forward.

PT-3 Brenda Jugoz

B. Jugoz testified as General Manager for PKA. The capacity of their current community center is 38, and they have 271 homes, and PKA's vision is to expand their facilities to serve more of their community members. She asked that the funds granted in December 2022 by the DHHL Commission be released.

Commissioner Teruya commented that B. Jugoz lives in Nanakuli and comes to Kapolei Community Development Corporation to use their certified kitchen. The funding they were awarded was to build a certified kitchen in PKA. B. Jugoz stated that is correct and wants to open it up to the other communities as well.

PT-4 Don Keliiholokai

D. Keliiholokai testified he had been a resident of Princess Kahanu Estates for 28 years. He stated that the funds must be released as their community center is a vital link for their community in Nanakuli and Wai`anae.

PT-5 Jeremy Makepa – G-4

J. Makepa is the President of `The Aina Alliance, one of the recipients of the grants approved in the December 2022 meeting. He is hopeful the release of the funds will be expedited to keep the coastline safe and cleared of abandoned vehicles. They also want to work on the access road to help create fire breaks.

Commissioner Neves stated that the funds are important to Anahola and would like to move the projects. Commission Awo asked if the hold-up is at Budget and Finance or the Governor's office. Chair Anderson stated his office would reach out to both.

Shayna Dela Cruz interrupted the meeting. Chair Anderson called for a recess.

Chair Anderson reiterated that he would check with the Governor and the Department of Budget and Finance.

Commissioner Teruya asked if the funds would not be released by the fiscal year and if they would lapse. She thinks that the Department must react to this. Grants Specialist Planning Office Gigi Cairel stated the funds for the grants are from a special \$10 million, and there is a deadline to encumber the funds by June 30, 2023, and staff does need a couple of months ahead of the deadline to prepare the documents.

Planning Manager Andrew Choy stated the question is best answered by Administrative Services, and currently, no one is available to answer. Gigi Cairel stated that Chair signed the requests on January 27, 2023; it was submitted properly and is at Budget and Finance and the Governor's office, where those two need to sign off on it.

PT-6 Brent Nakihei – Item G-4

G. Nakihei is the Vice-President of the Kalamaula Homestead Association to urge the Governor to release the funds for RFP-23-HHL-001 and 002. They are looking forward to the release of the funds.

PT-7 Malama Solomon – Act 279

M. Solomon testified on Act 279 regarding their request for an appropriation of \$2 million to fund the geothermal energy project. They strongly believe the \$600 million will not be able to address the total waitlist. The geothermal energy project will generate an ongoing revenue stream, targeting the wait list and getting single-family homes built with affordable mortgages and development funds for infrastructure for the build-out of homesteading programs. Stage 1, verification of location, and Stage 2, capacity, are the high-risk components for geothermal energy, and the private sector will not invest unless there is verification of location and capacity. The private sector will follow with DHHL as the lead along with other entities.

Commissioner Awo stated he thought he heard the term high-risk and private companies do not want to invest and asked if he would invest his money in a high-risk venture like this. If this is what he heard, the question to the Commission is whether it would want to set aside \$2 million intended for specific purposes and risk that in what is described as a high-risk venture.

M. Solomon stated the \$500,000 pulled down would define the location, and the \$200 million will give them entry for exploration which should trigger \$100 to \$150 million in grant monies from the federal government. The Biden administration is in support of firm renewable energy. It mitigates risk if they can perform all of those stages, she explained, which she stated they can.

PT-8 Robbie Cabral – Item F-3

R. Cabral testified on behalf of Innovations Development Group (IDG) to support Act 279 to explore Hawaiian home lands for their geothermal potential. The opportunity for the project allows for uniting a state energy grid as grids are separated by islands under the ownership of Hawaiian Electric Industries, Inc. (HEI). It allows Hawaiians to be at the helm dictating their self-determination in developing their assets. The project is a \$3 billion project, and the request to the Department is to explore the next steps with the \$2 million in the exploration of DHHL land assets. The Department will decide how the land is developed and with whom.

PT-9 Mililani Trask

M. Trask testified that she is happy to see the passage of the Act that will provide a revenue stream for the construction of homes needed. \$600 million sounds like a lot of money, but to her estimate, it will cost a little more than \$7.2 billion to address the needs of the 29,000 on the waiting list. The way to do this is to look to the development of renewable energy resources in the state and use it as a dedicated revenue stream for the Department in the future. The United States set the deadline for renewable energy, and at the top for renewable energy resources for the US Indo-Pacific Fleet is Pearl Harbor, O'ahu. Hawai'i has the greatest geothermal resource in the United States.

Commissioner Ka'upu asked for clarification that SCHHA and AHHL, the wait list association, opposed this project by the Department and Commission. He thought the SCHHA favored the project, but they are opposed. M. Trask stated she has calls from the SCHHA members stating the \$600 million should go to those who can qualify now. She stated it is not enough revenue stream to build a home for everyone on the list.

Commissioner Teruya wondered if the Legislature received the request for the geothermal from the PIG and if it was addressed. Commissioner Neves stated this was not presented to the PIG and did not consider the geothermal. He is not willing to take any part of the \$600 million to put into risk.

Commissioner Namu'o stated she supports the plan and has no deviation from the plan.

Commissioner Helm stated he does not object to new proposals such as geothermal, but the Commission needs to stick to the Strategic plan with Act 279.

Commissioner Ka'upu stated he was on the PIG, and the plan by design was flexible, with 10% flexibility for proposals from the beneficiaries on how to spend the money. Most comments were to do rentals, but rentals do not take people off the waitlist. This proposal for geothermal could fit into that 10% flexibility.

PT-10 Kalehua Krug – Item G-4

K. Krug is the Principal of Ka Waihona o ka Na'auao Charter School in Nanakuli. His request is to urge the release of the funds as they were awarded \$1 million for a certified kitchen. The school has 650 students, and 90% are native Hawaiians on the Waianae coast. They teach the students to grow food and prepare food for nutritional, physical, psychological, and emotional well-being. They have been doing fundraisers to match the \$1 million.

PT-11 Faith Tuipolotu

F. Tuipolotu is the President of the Moloka`i Homestead Farmers' Alliance and testified that they are also awardees of RFP 23-HHL-001 and 002. She thanked the Department and the Commission for their support through the years. They also urged that the Governor release the funds.

PT-12 Rose Davis

R. Davis testified she is with the Moloka`i Homestead Farmers' Alliance and she echos the words of President Faith Tuipolotu for the Governor to release the funds to continue the work on Lanikeha.

PT-13 Grace Gomes – Item F-3

G. Gomes testified on behalf of the Paukukalo Homestead Association, a'ole, to use Act 279 funds to conduct a geothermal exploration program.

PT-14 Michael Kahikina

M. Kahikina testified he heard \$2 million and is here to oppose it. He requested the Governor release the funds.

PT-15 Kanani Kapuniai – Item F-3 and Item G-1

K. Kapuniai testified the State's goal for renewable energy shall not be on the backs of the wait listers. What the Department can provide for the wait listers shall be funded by the General Fund and developed on Hawaiian home lands. The Commission and the PIG need to review the recommendations by the beneficiaries' plan. She opposed Item F-3 and used the funds for geothermal research. She supports Item G-1 for a water division. For Item C-2, she stated the report needs help as it lacks important information.

PT-16 Germaine Meyers

G. Meyers is a Nanakuli Homestead lessee. Her concern is that the Chair-Designate Anderson withdrew his nomination and is no longer an Interim. Chair Anderson stated he was designated and is now Interim. She continued explaining the Constitution says that he is not allowed to manage the DHHL as an Interim when the Senate did not confirm him, so by withdrawing, he is no longer an applicant asking for a confirmation, according to Article 5, Section 6, paragraph 6: no person who has been nominated, or appointed to any of the offices and whose appointment has not received the consent of the Senate, shall be eligible to an Interim appointment, after that to such an office. She stated that she needed clarification because of the legitimacy since a Deputy Director and a Vice-Chairman could manage this meeting.

Regarding the Minutes, he failed to address it in Maui when she brought it up to the Commission. She wants it addressed now because she is concerned about our assets, dollars, and lands being discussed at this meeting. The executive session minutes are still not being put on the agenda for approval like OHA, which states during the executive session, we will discuss the executive session minutes for approval for its validation, accuracy, and everything. She hopes decisions have not been made in executive session because, according to Sunshine Law, decisions are not supposed to be made unless it is related to termination and certain specific instances, but not everything. She asked for clarification.

DAG Kanaka`ole stated Ms. Meyers is not his client, so under Chapter 28, if there is a question from the Commission, we can answer that in executive session. Chair Anderson stated he did not have any questions. DAG Kanaka`ole stated addressed the matter before Ms. Meyers entered the building. He is happy to do that if the Commission wants to break for this.

Commissioner Awo stated this is an issue with some beneficiaries. Under Article 5, Section 6, he asked what section was being cited and what language led the Attorney General to its current decision that supports the Interim Chair when questions continue to arise about the legitimacy.

DAG Kanaka`ole clarified that under the Governor's Interim appointment, the Attorney General concludes that the Chair-Designate is the Interim Chair until either a new appointment or the end of the session. The same Article Section 6 is the authorizing language of the Constitution that allows this meeting to go on.

Commissioner Awo stated what he thinks he is hearing from the Attorney General is that if the Senate fails to confirm, it is inferring that a committee does not constitute the Senate. Since Interim Chair did not come out of the committee, that does not meet the threshold of the Senate. DAG Kanaka'ole stated that was correct. There would be a need for a full Senate vote that has not occurred and will not occur, and therefore he will be an Interim until he is replaced by a new appointment or end of session pursuant to the Constitution.

G. Meyers stated she disagreed because he withdrew his application. DAG Kanaka`ole thanked G. Meyers for her testimony and asked if there were any questions from the Commissioners.

Commissioner Kaleikini asked if a beneficiary disagrees with the Department and the Attorney General's interpretation of Article 5, Section 6, what recourse do beneficiaries have to follow up on their disagreement? DAG Kanaka'ole stated he did not want to expose the State to liability and passively advise Ms. Meyers of her legal options.

Commissioner Awo commented he does not want to be dismissive of concerns raised by G. Meyers, and he thinks it is legitimate issues and questions that should be brought to the table. He is not sure why the Governor put Chair Anderson in this awkward position, and the Attorney General has rendered an opinion, and he stated he read the Constitution. He does not always agree with the Attorney General. Still, the concern about the decision by the Governor to maintain Chair Anderson in this position will continue to raise questions.

PT-17 Homelani Schadael – Item F-3

H. Schadael testified she is not opposed to investing but is saying a'ole to Item F-3. Act 279 has a timeline, and it keeps shrinking. It is not the time to risk anything but to move forward. She has supported Act 279 and continues to do so, but is open to looking at future investments. The Legislature is mandated to provide the sufficient sums that the Department needs. She would rather that the \$2 million be used to form the new water division. She asked that the Commission get the funds released for the people.

PT-18 Kapua Lauifi

K. Lauifi testified she supports the awardees from Moloka`i. She hopes that the funds can be released soon so they can continue their projects and programs.

PT-19 Blossom Feiteira – Various Concerns

B. Feiteira testified in support of Item F-1. She is in opposition to Item F-3 in its current form. She does support the idea of a continuous stream of funding as long as the lands are determined to be undevelopable for homesteading and not in conflict with traditional and customary rights. Using Trust Fund monies to fund this activity would be more appropriate. Any opportunity the

Department and Commission have to establish long-term funding resources for developing homestead lands is always a good venture. The reservation of 10% for beneficiary services does not fit the criteria. She supports Item G-1, establishing a water division. She supported Item G-2 and asked the Commission to support this effort. Item C-3, for information only, has great information and opportunities. She is in support of Item F-4.

PT-20 Kawehi Correa

K. Correa supported the funding for the flexible amount in the Strategic Plan. She employed everyone to put their projects on the table and create a sustainable plan, figure out the best project in terms of sustainability, and money-generating opportunities to provide the offsets to the cost needed to help the people. She supports geothermal and sustainability investments that will perpetuate longevity now and in the future. We need electricity in Hawai'i; sustainability is the only way to do that in the future.

PT-21 Malia Greenie

M. Greenie testified (audio difficulties)

PT-22 Kekoa Enomoto – Item F-1 and F-3

K. Enomoto is the Chairwoman of Pa'upena Community Development Corporation and seeking an extension of their Right-of-Entry to complete their due diligence and archaeological survey. Tanya Lee Gregg is the investigator of `Aina Archaeology and stated that her firm is looking to finish the archaeological survey at the end of March. She asked the Commission to approve the extension of the due diligence ROE. Regarding Item F-3, the Mokupuni Council is opposed to Item F-3. She is also the secretary of the SCHHA and announced that Kipukai Kuali`i would replace Robin Puanani Danner as Chairman of the SCHHA. As the SCHHA's Secretary, she was also tasked to write a letter to Governor Green affirming that however, he determines to proceed on the Director of the Hawaiian Home Lands, the SCHHA supports Governor Green. The SCHHA also supports Robin Danner and Maile Luuwai in that order to become the next Director of the Department.

PT-23 Jessica Andrade-Kahaulelio

J. Kahaulelio testified that her parents have been on the wait list since the 1980s, which is disheartening. Her parents lived in her home and asked why they were not on Hawaiian homestead lands in Kamuela. According to the Real Property tax office, so much land on the Kohala Mountain road is available in Kamuela, in North Kohala. Why does DHHL allow Kahua Ranch's 9,378 acres of pastoral land to be given to her dad?

PT-24 Kaleo Cullen – Item F-4

K. Cullen testified that he supports F-4, the Right-of-Entry for Rojac Trucking. They are kanakarun and kanaka owned.

PT-25 Malia Greaney

M. Greaney testified about the water development on the Ho`olehua water system project. She has been subject to significant adverse impact because of the water system project identified as Site 4 and also impacted by Site 3 as they both overlap. In Site 4 the road goes up the entire

length of her homestead and overlaps with Site 3 on the entire length of her backside. She has been working with DHHL trying to settle the situation and should be able to make some resolution to this and avoid any type of legal action. She asked for specific things and was granted them, but it was taken away again. She stated all the property that was destroyed on entry by Goodfellow Brothers, after the road is completed then she can go in and salvage all that she can. Things have not been settled yet, certain things go against the lease and there are so many concerns like Section 106 for the expansion of Site 3.

Commissioner Teruya called for a point of order and asked what agenda item she is speaking on. M. Greaney stated G-1 regarding the water division. It would be run out of the Molokai office and she has concerns about that. DHHL needs to take into account access to water when considering the water division.

RECOMMENDED MOTION/ACTION

Homestead Services Division Administrator Juan Garcia presented the following: Motion to approve the Consent Agenda items listed for the Commission's consideration.

Commissioner Teruya asked to look at Item D-9, No. 5. This is a transfer, and this name keeps popping up as having several leases, then selling it, then having a lease, then selling it.

J. Garcia stated the transferee, Theodora Awai, is Theodore Awai's daughter, and they both have received multiple leases via lease transfer transactions. Theodora has held three previous leases, which she transferred. She is not a current lessee of record, which allows her to receive a lease through transfer. There is no policy or rule currently that will prohibit her from receiving a lease as she is qualified, and the Department is moving forward recommending Lease 8184 to be transferred to her as the lessee requested.

Commissioner Teruya stated that if the Department does not have a policy, the Commission should have a PIG to address it. This is the 5th time it has come up with this Commission since 2019. It does not give opportunities for other native Hawaiians on the waitlist trying to get a house. It is abuse when someone buys a homestead and flips it for profit. The Commission should start talking about it.

Commissioner Awo stated the Commission has asked for policies on several things over the years, and often, not much changes. He supports a PIG to investigate this matter.

Chair Anderson stated that if the Commission desires to establish a Permitted Interaction Group (PIG), he is happy to do that.

DAG Kanaka`ole recommended adding it to the next agenda. When the PIG is established, then he can set who is going to be on the PIG and the purpose of the PIG. Chair Anderson asked if any Commissioner is interested in being on the PIG to send him an email and copy Leah. The Commission will discuss that next month.

Commissioner Kaleikini asked about Item D-5. No. 11, is it correct that he is an applicant from 2021. J. Garcia stated it is not a lease award by the Department, but he received a lease through a transfer of successorship. Commissioner Kaleikini asked about Item D-7, Reinstatement of Deferred Application. J. Garcia stated the Department lost track of the applicant until recently. Commissioner Kaleikini asked if Item D-10 occurred before Item D-9. J. Garcia stated they are simultaneously done.

Commissioner Teruya asked about Item D-8 and if the dates were when the application was submitted. J. Garcia stated it is the effective date of the person's application.

Commissioner Ka`upu asked if it would be proper to defer approval on those specific repeat people as part of this consent matter. J. Garcia stated there is no policy, and the recommendation is to approve.

Commissioner Teruya does not want to support D-9. Commissioner Ka'upu asked to pull just that individual out of D-9, but the rest are not repeats.

DAG Kanaka`ole stated under HHC Act Section 208, the Commission's authority is to approve transfers. Deferring the transfer till next month is the Commission's prerogative.

Commissioner Awo stated this is not a one-off and there will be more. Formulating a policy may or may not transpire. Suppose the Commission is going to defer this. Is the Commission setting a precedent to defer every other one that comes before the Commission with the hope that it will create a policy with no assurance that it will be created?

Commissioner Neves stated he has the same concerns, which could affect and delay some financing that may subject the Department to a lawsuit. The policy has not been established yet.

Commissioner Freitas stated this is an issue, and to avoid any legal ramifications that could jeopardize the Trust, we should implement a policy or analyze potential options we may have.

Commissioner Kaleikini stated he supports the input and asked if Item D-9 could be included in the executive session today and taken up after the executive session.

DAG Kanaka'ole stated because the motion is not on the floor yet, the Commission can defer action on D-9 until after executive session. The Commission can move forward on the remaining items.

MOTION TO AMEND

Moved by Commissioner Teruya, seconded by Commissioner Neves, to remove Item D-9 and take it for discussion in executive session.

Commissioner Awo stated that Lehua might know because he believes there may have been Legislative efforts to address this issue, and there was insufficient support. Commissioner Teruya stated this was a concern brought up in the WAM meeting.

Commissioner Teruya inquired about the fire, possibly due to the homeless living in the abandoned buildings. With the island-wide enforcement team, the Department can initiate some balance in the Moanalua/Fort Shafter area.

K. Albinio stated that Pacific Transfer could tear down the entire site because it protects the individuals using the property. Commissioner Teruya asked if Pacific Transfer would do the demolishing at their costs. K. Albinio stated condition number 4 shows a credit of \$150,000 for Pacific Transfer to demolish within six months. The Department is allowing them to use the vacant site for their trucks for the demolition, and once that is completed, the Department will get the property back. If the demolition is complete within six months and credit is still available, the Department will pay them the credit balance. The Department can lease out the property for a long-term lease. Commissioner Teruya stated Pacific Transfer had been a good tenant. K. Albinio stated the \$150,000 was just for the demolition as his amended recommendation. Commissioner Teruya asked that the enforcement team look at the Kilihau property to preserve it. K. Albinio

told him the property there should be demolished because it leaks and, through the years the homeless have ruined it, as well as the rains and floods.

Commissioner Awo asked how long the property had been vacant and the condition of the property when it was vacated. This could have been addressed sooner. He asked for the timeframe. K. Albinio stated as soon as they can get this right of entry issued, it could be done within six months. Commissioner Awo asked that this be accelerated.

RECOMMENDED MOTION/ACTION

Acting Land Management Division Administrator Kahana Albinio presented the following: Motion that the Hawaiian Homes Commission Direct the Department to evaluate whether Act 279 (SLH 2022) funds should be used to pursue geothermal resource development to generate revenue to reduce the homestead applicant waiting list.

K. Albinio stated there was a submittal back in December, and that information is included in this submittal. The direction is intended for DHHL staff to formulate a path that will justify appropriating funds pursuant to Act 279. The path and formulation shall be consistent with the following criteria:

- 1. Hawaiian Homes Commission PIG be established as determined by the Hawaiian Homes Commission
- 2. The process of if and when any renewable energy solicitation is considered is strictly guided by statutory requirements, specifically HRS 171-95 and HRS 171-95.3.
- 3. Engage with beneficiaries via the Beneficiary Consultation process, and
- 4. The Hawaiian Homes Commission set forth other criteria that are prudent and necessary.

Note: Commissioner Helm arrived 2:55 p.m.

DISCUSSION

Commissioner Awo opposed utilizing ACT 279 funds for this purpose. He appreciates the need to use geothermal, but the terms such as high risk, exploratory, and potential subject the \$2 million to risk. Why would the Department take that same risk if a private corporation says it is too risky? He asked that the Legislature support this as a line item. Act 279 was not intended to eliminate the entire waitlist but to reduce the existing list. There is much more work to do, and this is one step forward.

Commissioner Helm stated he does not see a problem with generating revenue for the Department, but he opposed using the Act 279 funds. Commissioner Awo agreed with Commissioner Helm and stated that he sees no value in creating a PIG to explore something he does not support. Time is better served to form a PIG to determine how the Department will encumber funds for the second year because there is a narrow window to use its time wisely. Most of the mana`o from the beneficiaries is to stick with the plan. They are waiting for listers and want to reduce the list. Commissioner Helm stated he received emails opposing this proposal.

Commissioner Neves opposed using the Act 279 funds for the proposed process. His concern is immediate, as the \$600 million is a one-time opportunity to do what the Department is supposed to do.

Commissioner Freitas stated he sees the benefit of this potential endeavor for future generations if this will remove resources that take away from the task at hand to service the beneficiaries and reduce the waitlist.

Commissioner Kaleikini stated he would support establishing a PIG to evaluate geothermal, and we are not committing to utilizing the \$2 million. He stated the communication with the Attorney General and Senator Dela Cruz sets the record straight: if this is not about appropriating the \$2 million, if it was to happen, it is part of Act 279, No. 5. It is not deviating. He understands the opportunities that can come from a geothermal project.

Commissioner Namu'o stated the Legislature gave DHHL the funds to address the waiting list. She supports Commissioner Kaleikini's idea of creating a PIG.

Commissioner Awo stated he read the Attorney General's opinion. The only opinion that matters is that of the Commission. He does not agree with exploration and utilizing Commission time when simultaneously the Commission will also be forming a PIG to determine how to encumber funds for the second year. That is more important. It is not that he does not see the proposal's value, but for the wait listers, the majority that has spoken, does this align with their concerns? Cl

MOTION

Public testimony – **Kainoa McDonald** is a wait list beneficiary who serves as an executive member of the Association of Hawaiians for Hawaiian Homestead Lands (AHHHL), a member of the SCHHA. AHHHL stands in opposition to Item F-3. Every dollar of Act 279 should be spent immediately, getting lots issued to native Hawaiians. A special call to action was issued, and on February 20, over 84 waitlist beneficiaries, current homestead lessees, and successors completed a survey, and 90% of the data established a strong opposition to agenda Item F-3, in the 203 pages documented submitted yesterday in accordance to the instructions on the DHHL website. Her testimony and the 203-page document show strong opposition to agenda Item F-3. Act 279 funds must remain true to their purpose, and OHA funds are recommended to pursue geothermal development. She opposed the PIG for future study and extended her mahalo to Commissioner Awo for recognizing the petition of the wait list beneficiaries.

Public testimony – **Faith Chase.** She extended mahalo to the previous testifier for clarity and work on the petition. Getting homesteaders in their homes and reducing the wait list is important. Some homesteaders and beneficiaries are struggling in central Maui and are excited to see what is coming. There is hope that has been absent for a long time. There are other sources of funding and investors to help with the climate and energy situations, but she does not feel this is the right place. For lack of a better word, she thinks it was because it was low-hanging fruit. She also disagrees with creating a PIG. After all, there are many other ways that can be explored for funding in this space.

Commissioner Awo does support geothermal but does not support using these funds for that purpose. He asks that the money comes in a separate set aside.

Commissioner Kaleikini stated the Commission is just evaluating and not committing to using the money. If that ever comes up, it would have to come before this Commission. He agrees that setting up a PIG for encumbering money should be the priority. He opposed the motion on the table.

Commissioner Awo stated that the time spent doing an evaluation with the interest of setting aside \$2 million, it means holding up \$2 million until a determination is made, which constitutes a delay.

Commissioner Freitas asked if the Commission were to move forward with the PIG committee and go through the evaluation process, would we have to use 279 monies to move forward and actually do a more in-depth \$2 million research into it, or can the Department go back to the Legislature and ask for money the next session or after that.

Chair Anderson stated nothing prevents the Department from going to the Legislature in the future. The item being considered is to direct the Department to utilize 279 funds. A no vote signifies non-support. He stated he would be supporting the East Hawai'i island Commissioner.

Commissioner Teruya asked for a roll call vote.

ITEM G-1 Support Establishment of a New DHHL Water Division

RECOMMENDED MOTION/ACTION

Planning Manager Andrew Choy and Grants Specialist Gigi Cairel presented the following: Motion that the Hawaiian Homes Commission Support the Establishment of a New DHHL Water Division

The Department's four water utility systems are Ho'olehua PWS, Anahola Farm Lots PWS, Kawaihae Unit #1 PWS, and Pu'ukapu Water System PWS. The systems serve about 900 beneficiaries. The proposal is to add a Water Division as the Department currently has three divisions, Homestead Services Division, Land Management Division, and Land Development Division.

A total of twelve (12) positions are proposed for the new Water Division. The current operating budget for the DHHL water systems is \$5.3 million. When the new division is established, the Department could save \$900,000 by using State General Funds for payroll.

Next steps: (1) form an internal working group to refresh and update the water division proposal; (2) submit a formal request for review and approval by B&F; and (3) DHHL initiates the establishment of the new Water Division, according to the HR checklist. The overall timeline is 18-24 months.

DISCUSSION

Commissioner Helm stated he received emails from beneficiaries and associations on Molokai who need some time to review the documents for the water division so they can understand it better. He stated they also have concerns about MIS. He asked that this item be deferred to next month's meeting to make any decision.

G. Cairel deferred to the Chairman for any review of drafts as it is in the concept stage, and it is up to the Chairman at what point he would like to release a draft. A reorganization is done internally and is a department-level decision. The Department has nothing to do with the Moloka'i Irrigation System (MIS), as it is owned and operated by the State Department of Agriculture. Chair Anderson asked that this decision not require the Commission's approval. A. Choy stated it does not require Commission approval. However, last month there was a lot of vocal support by the Commission, and the Chair offered a gesture to support the Commission's sentiment on the concept of a water division. So, as a follow-up, the staff decided to put it on the agenda as general support.

Commissioner Neves stated he thinks it would be a good idea to have a representative from every island involved in discussions as it moves on.

Commissioner Teruya asked Gigi if she could find a number regarding the delinquencies. G. Cairel stated that out of the 900 customers, 40% on every system is delinquent, which is about \$1 million at the end of fiscal 2022. That should be revenue for the Department. Commissioner Teruya said she heard Gigi say construction does not pay for water. G. Cairel deferred to Land Development Division (LDD).

Acting Administrator Land Development Division Stewart Matsunaga stated that for the Ho`olehua project, the Department included water to the contractor at no charge. In the contractor's scope of work, they need to meter the water, coordinate with the Moloka`i District Office, and submit water usage records. If the contractor is charged for water, they will charge the Department back.

Commissioner Helm asked if it would be possible to go to Moloka`i so the people of Moloka`i could be involved in the process and ask questions. A. Choy stated the proposal does not fall into

any of the four categories for a Beneficiary Consultation. However, it does not preclude the Department from talking stories with the beneficiaries. If the Department does have a conversation with the beneficiaries on the water division, it should anticipate and expect a larger conversation on water.

Commissioner Awo asked how the Department will enforce the delinquencies because our enforcement is a band of one, Kip. Chair Anderson stated they are working on beefing up staffing in enforcement. There was one person who came on but did not last 48 hours.

Chair Anderson stated Item G-1 will be deferred until next month at the request of Commissioner Helm.

ITEM C-2 For Information Only – 2023 Legislative Session Update

RECOMMENDED MOTION/ACTION

None. For Information Only. NAHASDA Government Relations Program Manager Lehua Kinilau-Cano presented the following:

The Commission approved ten legislative proposals, nine of which have a vehicle to move forward. Proposal No. 2 for the Commission on Water Resource Management does not have a vehicle to move forward. She and Deputy Ducatt has been meeting with Legislators to inform them of the Department's package and budget priorities.

Proposal No. 05 only focuses on Administrative Rules and does not remove any Chapter 91 Rules. The Department would go through Beneficiary Consultation, and at that point, there would be an Interim Administrative Rule.

Proposal No. 07; does not change the Hawaiian Homes Commission Act in any way. One still has to have the minimum blood quantum and relationship to receive or be a successor of a home. All this is doing is addressing familial relationships. HB 567 is called a DHHL Omnibus Bill, an all-in-one bill.

DISCUSSION

Commissioner Teruya asked about SB-1040, where it is, and if the amendments were submitted. L. Kinilau-Cano believes it will be used with a rent-with-option to address the waitlist. L. Kinilau-Cano stated the Bill was related to homelessness. Commissioner Teruya asked how you define homelessness. L. Kinilau-Cano stated there are different definitions for homelessness even within the federal government. Commissioner Teruya stated it specifically had for the Leeward Coast and no other area.

PUBLIC TESTIMONY ON AGENDIZED ITEMS

PT-1 Francine Escualardo – Status on Waitlist

F. Escualardo wanted to know her status on the waitlist for a house or property. Chair Anderson asked Juan Garcia and Stacelynn Eli to assist Ms. Escualardo.

PT-2 Julie Louie – Payment Dispute Kalaeloa Right of Entry

J. Louie is the Office Manager at Aiwohi Brothers Trucking in Barbers' Point. She asked to resolve a payment dispute with their account. She asked for an audit of their account but did not get it. They are current with their rent; however, their electrical bill does not balance. They get billed for electricity, sometimes eight or six months at a time. One page of the spreadsheet shows they owe \$13,000; on the other page, it is cleared. They were billed for three transactions in 2016, but when looking at the printouts in 2016-2018, the transactions do not appear. Their account never looks balanced. She asked for a statement and was told the Department does not reprint statements. It has been happening for years, and she hopes someone can fix it.

Commissioner Teruya asked if she had received a letter from the Department that her ROE would expire due to the delinquencies. J. Louie stated they did receive that letter dated January 20, 2023, but they were current with the rent on January 19. They cleared six months of their electricity bill.

K. Albinio clarified that the Department mailed Aiwohi Trucking the notice. The information in the letter did not record the payment. Chair Anderson asked if the Department received the payment, and K. Albinio stated he believed the Department received some payment but not curing the exact amount in the notice. J. Louie stated the exact amount was \$69,000; they paid about \$40,000, and there are checks that the Department has not yet received. The rent is current, but the utilities are not.

Commissioner Neves asked to go into an executive session.

Chair Anderson relayed to J. Louie that she is on the J-Agenda and can return to speak there if she wants and to bring whatever documents she has.

PT-3 Donna Sterling - Item F-4

D. Sterling stated she supports Item F-4 for Rojac Trucking and is an applicant with the Board of Reclamation. She read off a list of people, thanking them for their support and helping move the project forward. She asked that the Commissioners favorably approve Item F-4.

PT-4 Puni Kekauoha – Item G-5

P. Kekauoha stated they are here on behalf of their community in Papakolea, Kewalo, and Kalawahine. Kula No Na Po'e Hawai'i was awarded \$447,344 for their Hookele project to address safety concerns for their kupuna. In 2 years, they were able to house 30 homeless people that were from Papakolea safely. During that time, the community saw what was happening and asked for help, so the project expanded.

Commissioner Namu'o thanked P. Kekauoha for the excellent work done in Papakolea.

PT-5 Jessica Andrade -

J. Andrade testified that her parents had been on the wait list since 1980. She asked why lands in Kamuela, Waimea, are not being awarded as she checked the County of Hawai`i's Real Property list and found hundreds of DHHL lands with no beneficiary names. Why?

Commissioner Freitas stated that the unexploded ordinances (UXO) hindered the Department from making awards in that area. The Department went through a process with the Army Corps of

Engineers (ACOE) who assessed the Lalamilo area and lots should be there sooner or later. The ACOE is also assessing and analyzing the Pu'ukapu area too. Once the UXOs are cleared and the Department gets the green light from the ACOE, the Department can start work and award lots. He is not sure about Kahua Ranch. She asked that he investigate that.

PT-6 Mapuana Tecter

M. Tecter spoke on behalf of her Aunty Norma, who is battling cancer, her mom, who applied for NAHASDA and never received it, and her late brother, who never received his home. Her Aunty was given an opportunity for a turnkey but could not do so financially. Her mom should have gotten her NAHASDA to repair her home but never received it. Chair Anderson stated if she leaves her documentation with staff, it will be given to the Beneficiary Outreach Coordinator, Stacelynn Eli, to follow up.

Commissioner Teruya stated the contact person she needs to call for NAHASDA is Cynthia Rezentes.

PT-7 Bo Kahui

B. Kahui stated he has been waiting for his ROE for pastoral land for a long time. Several ROEs manage thousands of acres that he does not think is fair as a beneficiary. He will continue his time on the J-Agenda.

Commissioner Kaleikini asked to reconsider Item F-3 to establish a permitted interaction group for geothermal and remove any reference to using Act 279 monies. DAG Kanaka'ole stated the reconsideration would have to be made at the end of the agenda, and he would have to look at the voting sheet to see who can make the motion.

Commissioner Teruya asked to clarify that it was Robert's Rules and that the motion maker would reconsider it. Chair Anderson stated DAG Kanaka`ole would check and issue a recommendation.

Rojac Trucking needs a Right-of-Entry permit for a half-acre site by the main gate at Kahikinui to provide the contracted service.

None. For Information Only. Acting Land Development Division Administrator Stewart Matsunaga presented the following:

The submittal provides a background of Act 279 and the implementation status as of February 13, 2023. It shows updates in terms of progress, meetings, encumbrances in process, the funds encumbered, and the funds expended. The Department was allotted \$172,750,000 million, which the Governor released in early January 2023. The projects have gone out to bid and are contracted, and funds are being encumbered as he speaks.

DISCUSSION

Commissioner Teruya asked if the park recommendation for Kaupea had been settled. S. Matsunaga stated that the Department needs to provide at least 60 lots. If the Developer's proposal includes 60 lots and additional space, then they could consider a type of recreational area. They also must construct traffic signals at Puainako and Kapolei Parkway.

Commissioner Teruya stated she does not see the Maili Development project in the spreadsheet. S. Matsunaga stated the project is scheduled for the fiscal year 2024. This is for the fiscal year 2023. There is a strict deadline, and the Department wants to get through the first year's encumbrance. LDD believes they can do it.

Commissioner Helm asked if the total lots shown are for fiscal 2023. S. Matsunaga stated the total number of lots is 3,000 and does not include what is on the last page in red, noted as A, B, C, and D, about 300 lots which are not included in the total amount of lots. Should the Department add proposals A through E, it would add another 600 lots.

Chair Anderson asked if any of these lots were turnkeys. S. Matsunaga stated the Pu`unani subdivision included 137 turnkeys.

Commissioner Teruya asked if the Maili and Ewa projects have planning and design monies in those projects. Her concern is, are there construction funds for those projects? Real Estate Development Specialist Darrell Ing stated for Maili, they have planning funds encumbered. Construction funds for this project will come from Act 279. Ewa is further behind, and Planning Office is still working on it. The delay for the Maili site is the archaeological comments from the Stated Historic Preservation Division (SHPD).

Commissioner Ka`upu asked that LDD be available for an executive session to provide information regarding the submittal's last page on A, B, C, D, and E due to confidentiality.

S. Matsunaga stated once there is agreement on the project proposals, A through E. The budget needs to be amended because the Department will likely have to move funding from fiscal 2024 to fiscal 2023 if it can be encumbered this year. They do not know the final amount of water, so it

may slide into the second year versus encumbering it in the first year. Other projects may be delayed in terms of the encumbrance because of going through various negotiations.

Commissioner Awo asked if it was adequate time or should the Department still pursue the extended time to get through the encumbrance. S. Matsunaga asked to speak freely and stated the Department should pursue the extension because there are many unknowns. Year one is the low-hanging fruits the Department knows it can do.

REQUEST TO ADDRESS THE COMMISSION

ITEM J-2 Dayne Kahau – Lease Issue

D. Kahau stated he appeared before the Commission in 2021, and the outcome was for him to get a reconsideration. He has waited for eight months and wants to know why so long. The property in question is his dad's property.

DAG Kanaka`ole stated the Commission is in the process where after the individual makes a request, the Department comes back with a written recommendation, and the Commission deliberates on that recommendation. There would not be a hearing yet with parties.

DAG Kanaka'ole clarified with D. Kahau that the Commission received his request and notified you that they would review it. Today the Commission will review your request. There will be a determination today.

ITEM J-4 Simeon Butch Ramos – Kewalo Lease Concerns

S. Ramos stated that the former Chair promised him some information based on his testimony in December. Twenty years ago, the Department took some land from him, took down a wall, and has not yet paid him. He was told that if they made any improvements to the property, the Department would reimburse him. DHHL wrote him a letter saying they would pay him off. He could not accept it because he could not buy the rocks for that 20 years ago. He returned the check because if he accepted it, it said everything was done, but it was not. During the project, a big rock came down from the mountain and smashed one of his cars. Stewart has a picture of that. He has written five letters since September, and nobody has responded.

Chair Anderson asked to who the letters were addressed. S. Ramos stated to the Director via Cedric. He was told to get an estimate for a wall today, so he did that in September and got a contractor who put an estimate in for \$48,000, a 120-foot rock wall, 4 feet high.

The second issue is the Department is doing another project, and they want to go through his property. He told Cedric he would allow them to go through his property on two conditions; (1) pay him what they owe him; and (2) this is a temporary easement. He was told he could not do that. They are going to make it permanent. He will fight the Department if it tries to take it from him. He wants the Department to let him know soon if they will get this thing paid off or if they will not take his property.

Chair Anderson stated his office would work with him to ensure that he is connected with the appropriate staff and have someone from the Chair's office in that meeting so that he can sit with the correct staff and ask your questions and have your questions answered.

The Commission convened for recess for 10 minutes, and the Contested Case Hearings for approximately 90 minutes.

ITEM J-3 Blossom Feiteira – Sybil Lopez– Various Concerns

On Tuesday, January 21, 2023, Chair-Designate and his Secretary visited Ho'olehua, Moloka'i, in response to the Department of Health's safety concern. The property of concern is in the Leikukui residential area. She spoke on her behalf outside of her Official County hat and as the

SCHHA Vice-Chair. Neighbors were getting sick with respiratory conditions, asthma, hospitalization, and cancer. A kupuna living across the street from the affected property died. The source was unknown until the heavy rains made it prevalent that there was a toxic substance within the neighborhood. Behind the abandoned vehicles were drums filled with an unknown substance. The families affected are seeking legal counsel. Mr. Noah John Horner and his wife Tara want to share his testimony.

N. Horner lives in the Leikukui residential area. He asked if it was legal for the homesteader to store materials of the sort and quantity on homelands owned for residential purposes. If the answer is no, would it be considered a criminal matter, and if yes, would it be a County, State, or Federal law? He asked if the Department knew about the situation or if it was their first hearing. His understanding is that the origin of the products may have come from the DHHL facility on Moloka'i. At the time of disposal, there should have been a disposal certification that has not yet been generated. He believes the original contract was dated back at least 8-years ago. He believes procedures are to prevent these types of events from happening.

Commissioner Awo stated he had seen an email describing what was said. He stated the Department dispatches someone to investigate, and the results are returned to the Department for the Commission's consideration. N. Horner stated they are on Hawaiian home lands and residential property in the Ho`olehua area.

Chair Anderson stated he was informed of the situation on Monday, January 30, 2023, at about 4:00 p.m. The next morning, at about 6:45 a.m., he was on Moloka'i with one of his staff, and they looked at the property. They found, as was described, a truck on the Crabbe property, and in the back of the truck were several drums with some fuel substance that had leaked into the back. His office contacted the State Department of Health and the Attorney General. On Tuesday, February 14, 2023, the State Department of Health, working with a contractor, went to the site, removed the fuel from the back of the truck and the drums, and contained it into a shipping container on the Crabbe property. The Department of Health did some soil remediation, removed soil that was found to be contaminated, put the soil in boxes, and wrapped the boxes in plastic and tarps that are contained safely on the property. The Department of Health sent samples of the soil for testing, and as soon as the soil testing comes back, the Department of Health will work on the disposal of the soil. The Department of Health needs to determine what is in the soil to dispose of it. From the Department's records, he understands this issue goes back to roughly 2015. During about 2-weeks, his administration has been able to get the area cleaned up in conjunction with the Department of Health and the Department of the Attorney General. That is where we are right now.

N. Horner stated that the Department of Health's official Terry on Moloka'i has been keeping him well-updated on his progress. He saw the shipping container leave Lei Kukui today, February 22, 2023, around 1:18 p.m.; it is off the DHHL property. They are awaiting the testing of the soil, and once it is determined what the materials are, the Department of Health can decide if it needs to be shipped out or if it can be dumped and buried at the landfill on Moloka'i. He is hopeful that the Department will hold the lessee accountable for his irresponsible decisions and the risk he posed to the health and safety of the residents.

Public testimony – Tara Horner. She found it disappointing that the Department was notified on January 31, and she received a letter dated February 17. It took that long for the Department to notify the people. The neighbor who lives next to the Crabbe residence informed the people that there would be removal. The February 17 letter notified the people that the removal came three days after the actual removal on February 14. The lack of urgency and communication was

disappointing. She stated several people died from cancer on the same street; another had nerve damage and an abscess. Communication would have made a big difference in how things played out.

Chair Anderson sincerely apologized for the information trickling to them. His administration focused on removing the material, safely contained, and doing the soil remediation with the Department of Health. T. Horner stated they hope to see the full report sooner than later. Chair Anderson stated this should not have happened and thanked everyone for their understanding.

Public testimony – William Kaholoaa Jr. (J. Kaholoaa) wanted to clarify that he called the Ho`olehua Fire Department requesting support for hazardous materials. He woke up with massive headaches, coughing, and respiratory problems. He has lived about 25-50 feet from the contaminated area for over eight years. After the Fire Department looked at it, he called the DHHL Moloka`i Office and asked Cindy Manaois if they had heard about it, to which she responded yes. He told her he had to leave home because of the toxic fumes. He told his neighbors they have hazardous materials in large quantities in the community. He is out of his home and paying out of his pocket. Who has the authority to render it safe for him to go home because he almost passed away eight months ago? It makes it hard for him to manage his job psychologically and physically as a dad, husband, and provider. His home still smells like fumes, and he was told he could go home, but who went into his home to test his home? He stated no one did. The Department of Health told him they are now in charge, not DHHL. Terry of DOH said they could go home, but Kaholoaa clarified that he wants to see written documents rendering his home safe to take his family home and that his community is safe. Is it safe for him to go home?

Chair Anderson stated he could not answer that question and had no expertise to tell him whether his home was safe. The Department of Hawaiian Home Lands does not have the expertise to tell you that. Chair Anderson's commitment to J. Kaholoaa was that he would work to get the hazardous materials cleaned up as quickly as possible. His other commitment was the Department would house him and provide hotel accommodation at the Department's cost until the hazardous materials were cleaned up. Upon checking with the Department's policies, it had none that allowed for housing a lessee, so he paid with his funds to ensure that he could honor his commitment to J. Kaholoaa to house him until all the hazardous materials were cleaned up.

The DOH shared with him that the fuel stored in the back of the truck was removed and placed in a shipping container, and all the contaminated soil that the Department of Health found was removed, put into boxes, and sent for testing. The boxes were secured and remained secured on Mr. Crabbe's property.

ITEM J-5 Lily Napoleon – Na'iwa Agricultural Subdivision Alliance

L. Napoleon thanked the Department for their time and energy in the Na'iwa subdivision and asked for its continued support. They started a homeowner/ag program to help people understand the cost of owning a home financially, and it is a 3-year project with Hawaiian Community Lending (HCL). They want to work with the College of Tropical Agriculture and Human Resources (CTAHR), Sustainable Moloka'i, and Hoopili Ag Foundation for the ag program.

ITEM J-7 Meghann Matsuda – Proposal for displaced individuals (slide presentation)

M. Matsuda asked for the Commission's support for their proposal for displaced individuals. They have been developing Pu'uhonua O Kaua'i, a Culturally guided Solution for Kaua'i's houseless. They are a non-profit called E Ola Pono Hawaiian Cultural Homes (E ola Pono HCH). The houseless used to be able to camp at various campgrounds for sixty (60) days with weekly breakdowns for campground cleaning. The goal is to start a camping model like Pu'uhonua O Waianae and then transition into a permanent tiny home village like Kau Hale. She understands that the biggest issue is being 50% Hawaiian. They want it to be for all Hawaiians. They can take 50% first and then go down the line. They are asking for a partnership in the land. She can email their full proposal.

Chair Anderson stated he had long been a fan of Kau Hale as a policy. He and the Governor, at that time the Lt. Governor, worked on an initiative in Waimanalo that has been successful and can be duplicated elsewhere. Hopefully, the Commission will consider a policy in the future.

ITEM J-9 Maxine Kahaulelio – Pu'ukapu Farm Lot

M. Kahaulelio stated she should go on next month's agenda because she is tired and will see the Commission next month.

ITEM J-10 Faith Chase – Maui Beneficiary Association

F. Chase is a full-time Kahikinui homesteader and is speaking on Item F-4. She appreciates the unanimous vote for the Right of Entry for Rojac Trucking. For public record, she helped the Kahikinui homesteader, Samuel Hanbeck, fill out the initial grant program application. As mentioned, the initial grant ask was very large. Because the Board of Reclamation Drought Emergency Relief Program did not have a monetary ceiling, he included many water efficiency pieces to the plan. The key is that Mr. Hanbeck's watershed request was so large his watershed management plan is considered an existing one. This means that an (indiscernible) can be made with the BOR water efficiency grant that ensures water delivery continues until the watershed is restored and can provide water permits along the moku. The water is not to be used for ungulate removal.

ITEM J-11 Robert and Sharmaine Taua – Nanakuli Lease Concerns

R. Taua and Charmaine Taua stated they filed a complaint to the Department's Enforcement Division via email on January 3, 2023, for the vandalism and trespassing of their property. On January 20, 2023, they dropped off a binder that included copies of police reports, a list of police trespassing reports, and vandalism on their property since the beginning of 2018. Since dropping off the binder to Ross Kapeliela, they have not yet received a response. Regarding the flooding of their property, Casey Corpuz asked them to forward their correspondence with the Department of Planning & Permitting (DPP) along with DPP's recommendations. DHHL's Enforcement informed the Tauas that it was a civil matter and nothing was done to address or rectify the problem. They have taken their concern to their representative, Council member, Chief of Police Ballard, and the Nanakuli Neighborhood Board. They have learned that DHHL protects Hawaiian homesteaders from trespassing and vandalism. They are personally notifying DHHL of the criminal acts being committed. Chair Anderson stated he would share with the Enforcement Team and follow up with the Taua family.

Public testimony – **Ainaaloha Ioane.** Updated the Commission on what is happening at King's Landing. She thanked the DHHL Planning Department for their Honu Waiakea process in partnership with the Edith Kanaka'ole Foundation (EKF) and Group G-70. They had a great 2-day workshop, and it was refreshing to look at the mele and oli of the kupuna and the mo'olelo of their ahupua'a of Waiakea. She asked if the Provisional Investigative Committee of King's Landing and DHHL Land Management Division Phase 2 had the opportunity to meet and discuss

the undivided interest, the MOU with Parks and Recreation to secure their gates, and also the MOU with HPD to begin the trespassing process.

Commissioner Kalekini stated that the PIG did not meet yet and would get back and see when they could meet again.

Appropriated by the State Legislature through HB 1600, HD1, SD2, CD1, then signed into law as Act 248, a portion of the \$10M will be used as a funding source for the DHHL Community Development Grants program to provide "services to existing homesteads" and to repair existing facilities on Hawaiian Home Lands. My name is Samuel Hambek, many friends call me Kamuela. I have one son, Kamuela Jr. Mahalo for this opportunity to share my experiences of building homes in Kahikinui, Maui and my passion to continue to build safe homes for homesteaders.

I was first asked to help fix Uncle Mo's fence. Uncle Mo lives all the way at the top of Kahikinui, his lot is at the 5000-foot elevation. At certain times of the year, there can be ice on the ground in the morning.

While I was helping Uncle Mo another homesteader saw me and asked for help with his house. Unbeknownst to me this would continue and continue. Homesteaders that needed help in this backside country saw my skill sets and asked for help. To date I have helped build, repair and roof five Kahikinui homestead homes. I have gotten to really know Kahikinui homesteaders and always answer the call for help. I also have provided water tanks and water delivery to those who have needed.

To be clear, I have enjoyed building homes for homesteaders. It brings me personal joy to see 'ohana gather, rest safely and enjoy beautiful Kahikinui.

My experience of building hale in Kahikinui has helped me develop realistic approaches to constructing in the off-grid region. Scheduling building around the weather elements takes special planning. The wind specifically takes incredible caution when doing roofing work. All these nuances of the homestead, of the mauna I have become comfortably familiar with.

I understand the goals of Act 279 and its intent to help homesteaders get on their 'aina to build homes and to reduce the waitlist.

While I have met some of the new Kahikinui homesteaders I just wanted to introduce myself to lend support to those newly awarded Kahikinui homesteaders.

It's a great time to be a Commissioner, it sounds like the support for Kahikinui homesteaders is on its way. It's been a long time that they have been waiting.

Mahalo for granting the ROE for Rojac Trucking. I produced the initial watershed drought plan for this Drought Emergency Relief Program grant and I'm glad everyone who has needed to partner understands how important it is for homesteaders to have water delivery. I must add and put it on public record that I am opposed to any of the water from the drought relief emergency program to be used for current ungulate removal activities.

I'd like to submit testimony on item G-4 Grants on behalf of AINA ALLIANCE as Board President. I hope to be able to give testimony over the livestream, however, if I cannot here is a summary of my thoughts.

Mahalo for approving the grant to AINA ALLIANCE. We have been working diligently to manage the coastal areas of Anahola with little to no financial help, just a strong feeling of kuleana to do what is pono for the land. We have struggled to secure the 400 acre project and must contend constantly with cut locks, broken gates, vandalism, illegal dumping and arson fires. The funds from this grant will help us to solidify the perimeters with gates and fencing while also creating a central access point for beneficiaries and others to enjoy the beautiful coastline. These funds will also help us to re-establish the fire break roads that have grown back and are nearly covered by vegetation since I initiated County and State agencies to help create them two years ago. These fire break roads will limit fire spread to keep neighboring houses safe from wildfire, and allow access for emergency vehicles to quickly extinguish the fires. They also make it easier for our volunteers to clean up tons of illegal dumping that had continued in this area for many years. I am hopeful that you can help expedite these funds so that we can work on these fire break roads before summer fire season begins.

Attached are photos of a few of the activities that happened so far in 2023.

- 1. Unauthorized people created new path through bush and trees to coastline and got stuck. Cars broke down and they abandoned the vehicles
- 2. Lock and chains were cut to gain access
- 3. Volunteers use skytrack forklift to remove abandoned vehicles from the beach
- 4. Students from Kanuikapono help to document abandoned vehicles
- 5. Organized 50 tourists on a retreat help to remove 4 trailer loads, and two truck loads of trash from an old homeless camp with Surfrider foundation.

I am Debbie Mahuna, and I would like to advocate on agendized item D-1 regarding Homestead Lease and Application Totals. This monthly report states that 540 undivided-interest lessees have moved onto homesteads, compared to 537 in January 2022, for a total of three new lessees during 2022.

I am Pu'unani Hawaiian Homestead Association president and a Maui undivided-interest lessee with first right of refusal to the planned 161 Pu'unani homestead awards. Therefore, the commission can anticipate adding up to 161 undivided-interest lessees moving onto homesteads starting with Pu'unani lot selections as early as summer 2024.

On behalf of the Pu'unani Hawaiian Homestead Association, I would like to advocate for an updated Maui undivided-interest list.

We are working with The Money Store mortgage brokers Anna Revilla and Misty Griffiths to have our undivided-interest lessees pursue mortgage pre-qualification letters; so they are prepared for Pu'unani lot selection starting in 15 months.

Both Anna and Misty reside on homesteads, at Waiehu Kou 3 and 2, respectively. They attend our association's monthly Zoom sessions and are committed to expedite our beneficiaries getting Pu'unani homestead awards.

An updated Maui undivided-interest-lessee list would make more efficient our efforts to research contact information, invite beneficiaries to meetings, and help them pre-qualify for construction and/or mortgage financing.

Mahalo e Commissioners for your kokua in enlisting the appropriate DHHL staff to provide an

updated list of Maui undivided-interest lessees, to empower these beneficiaries to be completely informed about, and prepared for, lot selection next year and home ownership.
